SOLUTION FOR INJECTION FOR CATTLE, SHEEP AND PIGS

PRESENTATION:

Each ml of suspension for injection contains:
 200 mg Procaine Benzylpenicillin,
 200 mg Dihydrostreptomycin (as sulphate),
 1mg Methyl Parahydroxybenzoate as preservative.

RECOMMENDED USE:

Indications for use:
 For the treatment of infections caused by bacteria sensitive to penicillin and dihydrostreptomycin.

CONTRA-INDICATIONS & WARNINGS

Not to be administered to animals known to be sensitive to penicillins. Occasional allergies to penicillins have been observed, but these are rare. Not for use in lactating ewes producing milk for human consumption.

RECOMMENDED WITHHOLDING PERIOD:

Animals should not be slaughtered for human consumptions for 21 days. Milk from treated animals should not be used for human consumption during treatment or 72 hours thereafter. The withholding period for milk relates to cattle only. Not for use in lactating ewes producing milk for human consumption.

DOSAGE AND ADMINISTRATION:

For intramuscular administration only.

SPECIES	DOSE (ml)	BODYWEIGHT(kg)
Cattle	4.0	100
Calf	2.0	50
Sheep	1.0	25
Lamb	0.4	10
Sow	3.0	75
Piglet	0.2	5

Clean the area of injection and swab with spirit. The maximum dose volume recommended at any one site for cattle is 20 ml.

DISPOSAL PRECAUTIONS: Unused products or waste materials should be disposed off in accordance with current practice for pharmaceutical waste under national disposal regulations. Use contents within 4 weeks when broached.

PHARMACEUTICAL PRECAUTIONS:

- Shake well before use.
- Do not store above 25°C.
- Do not freeze. Once a vial is broached, use the contents within four weeks.
- Wash hands after use.
- Keep out of reach and sight of children.
- Avoid the introduction of contamination during use.
- For animal treatment only.
